3. The tenure of the two expert Members will be for 2 years from the date of nomination. The State Level Executive Committee (SLEC) will be responsible for approving the annual action plans of the State before communicating to the Executive Council of the National Bamboo Mission at the National level for approvals and release of funds and ensuring effective implementation & monitoring the scheme.

4. Permission is hereby accord to the Chief Conservator of Forests (Development) & Mission Director, State Bamboo Mission, O/o the Principal Chief Conservator of Forests & Head of Forest Force Andhra Pradesh to set up Bamboo Development Agency (BDA) and to constitute the District Level Agencies.

5. The Principal Chief Conservator of Forest & Head of Forest Force, Andhra Pradesh shall take further necessary action in the matter accordingly.
